Members were emailed a written report and a copy of the Annual Accounts for the year ending 31st March 2025 before the meeting. Representatives at the meeting unanimously agreed to accept the Accounts and thanked David for his work as treasurer.

The treasurer thanked Sue Brown for acting as Independent Examiner for the Accounts. He proposed that she should be requested to continue as Independent Examiner. Unanimously agreed by representatives at the meeting.

## **Amendment to GLHA Constitution**

At the GLHA Committee meeting on April 2nd, it was agreed to recommend to members a change in the Constitution to include a reference to online banking. Paragraph 13 point (i) of the Constitution is worded as below.

### 13. Finance and accounting

(i) The funds of the Association, including all donations, contributions and bequests, shall be paid into an account operated by the Committee in the name of the Association at such bank as the Committee shall from time to time decide. All cheques drawn on the account must be signed by at least two members of the Committee who are authorized signatories.

The Committee recommended the following amended wording at that point:

## 13. Finance and accounting

(i) The funds of the Association, including all donations, contributions and bequests, shall be paid into an account operated by the Committee in the name of the Association at such bank as the Committee shall from time to time decide. All cheques drawn on the account or payments made via an online banking service must be signed or authorised by at least two members of the Committee who are authorised signatories.

The proposed amendment was agreed by all. The secretary would make the amendment and email the revised constitution to all.
